**Duties and Duration:**

The negotiated price listed in this agreement includes duties and items as outlined herein; as well as the date and time of service (no more than 1 hour in duration, from scheduled ceremony time). Ceremony must start within 30 minutes of agreed time. Officiant may not agree to overtime based on her schedule, and may leave without performing the ceremony.

**Cancellation Policy:**

In the event that the undersigned wishes to cancel the ceremony or that the ceremony cannot take place through no fault of "Officiant", the undersigned remains liable for a minimum scheduling fee of \$100. If the "Officiant" for some reason such as death, sickness, or accident beyond her control must cancel, "Officiant" will attempt to book another Officiant. If that is not possible all monies received will be returned to the Person A and Person B.

Once signed below, no changes can be made in this agreement, without written notification and approval, by the Officiant. This agreement cannot be canceled. This agreement is therefore considered by all said parties to be legal and binding in accordance to the conditions set forth herein.
